SUBSEQUENT INVESTIGATIVE INQUIRIES RESULTED IN THE DEVELOPMENT AND IDENTIFICATION OF AN ADDITIONAL TWENTY-FIVE FEMALE VICTIMS WHO WERE ASSAULTED. VICTIMS(b)(6). (b)(7)(C) (b)(6). (b)(7)(C) , (b)(6). (b)(7)(C) AND (b)(6). (b)(7)(C) WERE AMONG THE TWENTY-SIX VICTIMS IDENTIFIED DURING THE COURSE OF THE INVESTIGATION.

THE INTERVIEW OF V(1)(6), (1)(7)(0) ON 310CT91, DISCLOSED SHE HAS BEEN A MEMBER OF THE TAILHOOK ASSOCIATION FOR THE PAST 2 1/2 YEARS AND HAS ATTENDED THE LAST FOUR ANNUAL TAILHOOK CONVENTIONS. THE COURSE OF HER AFFILIATION WITH THE TAILHOOK ASSOCIATION SHE WAS AWARE OF WHAT IS KNOWN AS THE "GAUNTLET". THE "GAUNTLET" IS DESCRIBED AS A GROUP OF MILITARY OFFICERS WHO CROWD A HALLWAY FORMING LINES AGAINST THE WALLS AND PHYSICALLY/INDECENTLY ASSAULT WOMEN AS THEY PASS THROUGH. Vb(6,6)(7)(d) FURTHER RELATED THAT ON 05SEP91, AT APPROXIMATLEY 2100, WHILE IN THE COMPANY OF HER DATE, CAPT USMC, AND COL (b)(6), (b)(7)(C) (b)(6), (b)(7)(C) USMC, ON THE THIRD FLOOR OF THE HILTON HOTEL, AN INDIVIDUAL DESCRIBED AS HAVING A BRITISH ACCENT, WHOM SHE LATER LEARNED WAS ATTACHED TO SQUADRON VMF-101, BIT HER ON THE BUTTOCKS.
