

<p>LT, USN-PRIMARY VICTIM #1</p>	<p>07SEP91 AFTER 2330</p>	<p>PINCHED, GRABBED, FONDLED ABOUT THE BREAST AND BUTTOCKS. SHE BIT THE MAN WHO REACHED INTO HER BRA.</p>
<p>ENS, USN #2</p>	<p>07SEP91 2030-2400</p>	<p>GRABBED ON THE BREASTS, LEGS AND BUTTOCKS. SHE HIT ONE MALE IN THE FACE. A USN CAPT ALLEGEDLY WITNESSED INCIDENT BUT DID NOT STOP IT.</p>
<p>CIV #1</p>	<p>07SEP91 EVENING</p>	<p>INVOLUNTARILY PICKED UP ON A MALE'S SHOULDERS. GROPED ALL OVER BODY, BREASTS, CROTCH AND BUTTOCKS AND PUNCHED IN THE MOUTH.</p>

CIV #2	07SEP91 2215(APPROX)	GRABBED ALL OVER BODY, SKIRT PULLED UP AND CROTCH TOUCHED.
CIV #3	07SEP91 2215	GRABBED ALL OVER HER BODY, INCLUDING BREASTS, BUTTOCKS AND CROTCH. SHE THREW HER DRINK, DRINKS THROWN AT HER. SHE PUNCHED A MALE IN THE STOMACH.
CIV #4	07SEP91 1900-2100	VICTIM RESCUED FROM GAUNTLET BY UNIDENTIFIED MALE BELIEVED TO BE A PILOT. SHE ALLEGEDLY WENT VOLUNTARILY WITH MAN TO HIS ROOM AND SUBSEQUENTLY ALLEGED NON-CONSENSUAL INTERCOURSE. THE MAN WAS NEVER IDENTIFIED AND THE ALLEGED RAPE COMPLAINT WAS UNFOUNDED.

PRINCIPAL VICTIM VIEWED PHOTOGRAPHIC LINE-UPS ON SEVEN SEPARATE OCCASIONS. MOST SIGNIFICANT ONES OCCURRED:

ON 31JAN92 PRINCIPAL VICTIM ALSO VIEWED TWO PHYSICAL LINE-UPS CONSISTING OF SIX MINORITIES EACH. SHE POSITIVELY IDENTIFIED CAPT USMC AS HER ASSAILANT.

IN ADDITION TO THE OTHER VICTIMS, FIVE USN OFFICERS ONE USMC OFFICER, AND THREE CIVILIANS VIEWED PHOTOGRAPHIC LINE-UPS.
